The UK Department for Transport (DfT) is seeking to procure services to populate and maintain a central database of cycling data for the urban centres of Great Britain. In 2009 the UK Government programme Transport Direct is launching an online cycle journey planning service.

The service will be launched for 11 areas and then extended to other areas over the coming years. This database is first primed with data captured through surveys and then maintained by local authorities, data suppliers and the successful bidder. Transport Direct provide the central database and associated online management tools.

DfT is seeking to procure services to deliver and manage this database. These services are split into two work packages:

— Cycle data collection. Undertaking cycle surveys to extend the Ordnance Survey Integrated Transport Network to include information about existing cycling infrastructure and where cycling is permitted and recommended. Cycle data will be provided in accordance to CycleNetXChange specification (<http://www.cyclenetxchange.org.uk/>),

— Cycle data management. Managing the central database including coordinating data collection, journey planner publishing, data maintenance and quality assurance activities and managing local authorities and data suppliers. These activities are supported through the online data management tools provided by Transport Direct.

The bids for each work package will be independently evaluated and providers can quote for one or more package. Bids from consortia are welcome.
